### **DESCRIPTION**

This position involves skilled work under the direction of the Operations Manager. It requires an individual to work at a journeyman level, but also requires the capability and skills necessary to perform tasks in areas other than their designated trade.

The work is done under general supervision but requires some independent judgment as to the method of repairing School District equipment. An employee in this class may direct helpers and provide instruction to others.

- Provide detailed weekly/monthly/yearly work schedules for the maintenance of equipment using existing resources.
- Manage a preventative maintenance program and maintain records as it relates to the mechanical equipment of the District. (school buses, small vehicles, mowing equipment, school generator set and miscellaneous mechanical equipment).
- Ensure that this equipment is maintained to a standard acceptable to the Board and any regulatory authority having jurisdiction.
- Performs duties related to the trade.
- Operates a school bus transporting students in a safe and efficient manner
- Perform other assigned comparable duties which are within the scope of knowledge, skills, and abilities of this position
